**LICKEY END AIR QUALITY MANAGEMENT AREA (NITROGEN DIOXIDE)**

**ORDER 2001**

**SECTION 83(1) ENVIRONMENT ACT 1995**

**ORDER DESIGNATING AN AIR QUALITY MANAGEMENT AREA**

Whereas the Bromsgrove District Council ("the Council") is satisfied that as a result of its air quality review and assessment dated December 2000, the annual mean air quality objective for Nitrogen Dioxide is not likely to be achieved by 31st December 2005 (being the relevant period prescribed by the Air Quality (England) Regulations 2000) in the area described in the schedule below for reasons both of the current and projected exceedence of the objective.

Now therefore the Council in exercise of the powers conferred on it by section 83(1) of the Environment Act 1995, hereby makes the following Order.

**IT IS HEREBY ORDERED THAT:-**

- 1) The area shown shaded on the attached plan which forms part of this Order, and described in the schedule below shall be designated as an Air Quality Management Area, to be known as Lickey End Air Quality Management Area (Nitrogen Dioxide).
- 2) The Air Quality Management Area be specific to Nitrogen Dioxide only by virtue of likely exceedences predicted of the annual mean objective for the year 2005 in the range of 40.0 to 45.7µgm<sup>-3</sup>
- 3) The Order be cited as the Bromsgrove District Council (Lickey End Air Quality Management Area (Nitrogen Dioxide)) Order 2001.
- 4) The Order shall come into force on 26<sup>th</sup> July 2001, and shall remain in force until varied or revoked by subsequent Order.
